More than 100,000 children are waiting to be adopted from foster care in the United States. Every year, thousands of these young people turn 18 or 21 and age out of care without a permanent family, leaving them much more likely to experience homelessness, unemployment and other negative outcomes.

The Dave Thomas Foundation for Adoption is a national, nonprofit public charity dedicated to dramatically increasing the number of adoptions of children waiting in North America's foster care systems.

Supporters like you power the Foundation's work to raise awareness, promote educational resources, advocate for adoption and foster care benefits in the workplace and support the expansion of our Wendy's Wonderful Kids® program.

Through Wendy's Wonderful Kids, the Foundation supports the hiring and training of adoption professionals who serve the longest-waiting children in foster care. A five-year, national evaluation revealed that children referred to the program are **up to 3x more likely to be adopted.**
